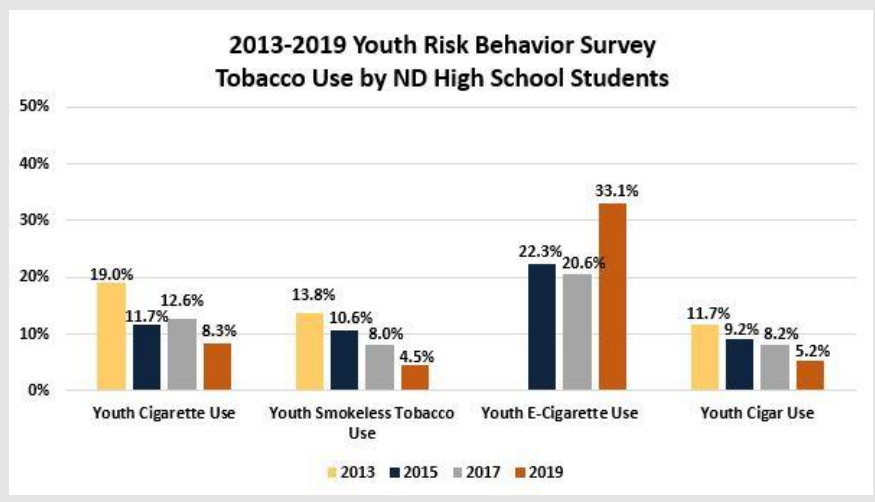
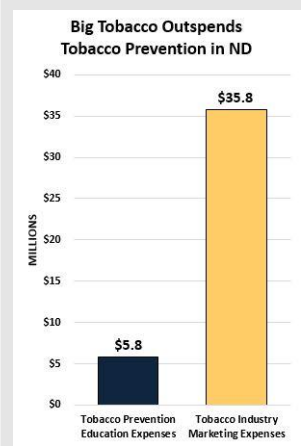

What can North Dakota do to protect youth?

-  Increase the price on ALL tobacco products including e-cigarettes, vapes, and MODS
-  Fund tobacco prevention and control programs at levels recommended by the CDC
-  Maintain the ND Smoke-Free Law
-  Restrict flavored tobacco products
-  Implement Multi Unit Housing Smoke-Free Policy
-  Raise the minimum legal sales age to purchase tobacco to 21
